1. ORGANIZING AUTHORITY

Sailing club »Lahor« Sv. Matija, Dobrota 85330 Kotor

2. ADVERTISING

WS Advertising Code will be applied. All boats shall be obliged to display their bow numbers and flags which will be assigned to them at registration.

3. RULES

- 3.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing 2021-2024, this Notice, and the Sailing Instruction.
- 3.2. Usage of canting keels and movable ballast is permitted for racing monohulls. This changes rule 51 RRS.
- 3.3. If there is a conflict between languages the Montenegrin text will take precedence.

4. ELIGIBILITY

- 4.1. All monohulls and catamarans with a valid boat registration are eligible.
- 4.2. All skippers shall be registered with their national sailing authority.
- 4.3. Regatta is open for the following classes:
 - Traditional sailing boats in 2 categories by material: WOODEN and PLASTIC
 - Cruisers grouped by LOA (OPEN)

OPEN 3	6.91 – 7.90 m

- 4.4. Two boats are required to constitute a group. If this requirement is not met, a boat will be moved to the nearest higher group.

5. REGISTRATION

- 5.1. Entries will be accepted through the official website fasinadacup.com or by e-mail.
- 5.2. Registration
 - July 20th 17:00–20:00 at RC office in "Dom vojske" in Tivat
 - July 21st 09:00–10:00 at RC office at main square in Perast.
- 5.3. All skippers shall present proof of registration at their national authority, a boat registration document, and proof of fee payment.
- 5.4. Late entries will be accepted only if RC finds the delay justified.

6. FEES

- 6.1. The entry fee is 20 € per crew member if registered before July 21st
- 6.2. The fee for entries accepted on July 21st is 30 € per crew member.

9. SAILING INSTRUCTION

Sailing Instructions will be available during registration.

10. SCORING

The low point system will apply, according to Appendix A RRS.

11. RACING AREA

Bay of Kotor, along the route Perast-Tivat.

12. COURSES

Attached to the Sailing Instructions.

13. AWARDS

- 13.1. The fastest monohull will be awarded the trophy »Fašinada Cup«.
- 13.2. The first 3 boats in every class will be awarded an appropriate trophy.

14. MEDIA RIGHTS

The organizer has the right to use photographs, video and audio documents of competitors and boats during the event in the media, including advertising and press materials for any other publicity or press releases.

15. LIABILITY

All those taking part in the regatta do so at their own risk and responsibility. The organizing authority nor their representatives will not accept any liability for material damage, personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

16. BERTHING AND PERMITS

- 16.1. Free-of-charge berthing will be provided at Porto Montenegro Marina from July 20th to July 23rd to all participants. Berths shall be booked before July 13th directly through Porto Montenegro's booking service, by sending an e-mail titled "FC2024 competitor" to marinabooking@portomontenegro.com with the following information: Boat name, LOA, beam, and draft; Owner's/Skipper's name, e-mail, phone number.
- 16.2. Foreign boats will be provided a permit to sail through Montenegrin waters during the regatta, under the condition that they register no later than July 20th.
